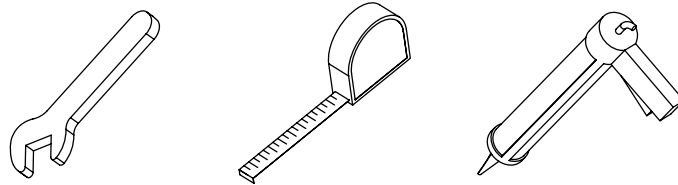

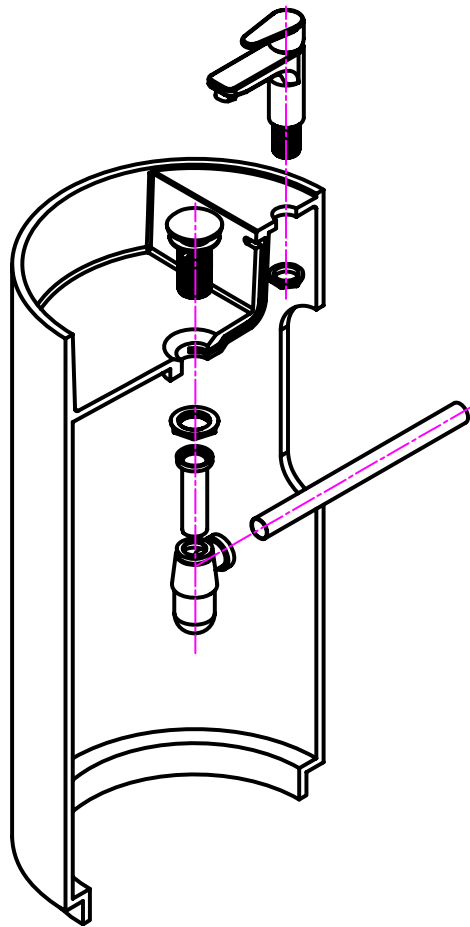

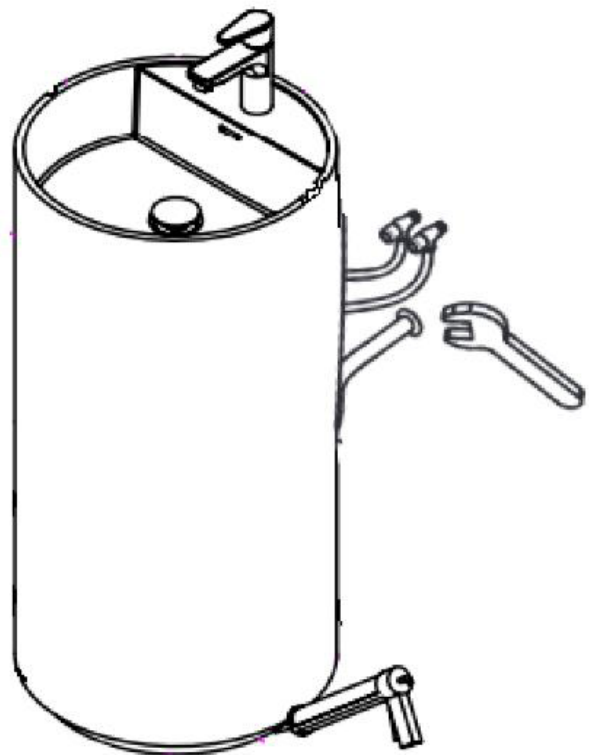
Check where the sink will be installed. Install the water inlet hoses. Put the nuts and washers on the pipes, pass them through the tap hole from bottom to top. AT Connect the faucet with the water inlet hoses. Secure and tighten the faucet. Through the rear cut hole, install the drain and P-trap.

Move the sink to the desired location, connect the hoses (cold and hot) to the wall inlet. Connect the P-Trap to the water outlet on the wall.

Water test

- 1) Open the cold water supply
- 2) Open the hot water supply
- 3) Open the faucet to see if there is any leaking water
- 4) Check the drain to see if there is a leak.

Apply silicone around the base of the sink. Wait 24 hours for it to dry.



PRODUCT MAINTENANCE

Wipe the surface with a soft cloth after each use. Use mild cleaning products. For more difficult stains, use a mild abrasive cream cleaner. Never use petroleum-based cleaning products, such as paint thinners or other solvents, as these can damage the solid surface.

LIMITED WARRANTIES

Odass warrants the product to be free from defects in workmanship from the date of purchase. These warranties extend only to the original owner/end-user for personal household use and start from the date of purchase/billing. This warranty cannot be transferred to a third party and additional limitations apply for commercial uses.
